ORDER:



The Revenue Divisional Officer, Sircilla through the reference 3rd read above has submitted that, the Declaration was published on 23.03.2018 for acquisition of 450333.21 Square Yards for construction of Ananthagiri Reservoir under Kaleshwaram Project, Package No.X in the limits of Ananthagiri village of Ellanthakunta mandal U/sec. 19 (1) of the RFCTLARR Act 30/2013 (Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017).

Further the Revenue Divisional Officer, Sircilla has submitted that the Voluntary / General Award and R&R Award could not be passed within the stipulated time i.e. from the date of publication of Declaration due to various reasons likewise General Elections to TSLA, 2018 and non availability of required funds. Hence he has requested to accord permission for extension of time of the Declaration for another (12) months U/sec. 25 of the RFCTLARR Act 2013, so as to enable him to pass the Voluntary / General Award and R&R Award for balance extent situated at Ananthagiri village of Ellanthakunta mandal.


On verification of records, it is revealed that the Declaration was approved and published on 23.03.2018. As such the Authorized Officer / Revenue Divisional Officer, Sircilla shall make a Voluntary / General Award and R&R Award within period of (12) months from the date of publication of Declaration. But the same could not be done by the Authorized Officer / Revenue Divisional Officer, Sircilla.

The Circumstances reported by the Revenue Divisional Officer, Sircilla has been examined with reference to the record and justified the same, consequently the extension of the time for Declaration published on 23.03.2018 for acquisition of land for construction of Ananthagiri Reservoir under Kaleshwaram Project, Package No.X in the limits of Ananthagiri village of Ellanthakunta mandal, which is a flagship programme of the Government and contention of the Revenue Divisional Officer, Sircilla is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 25 of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Declaration published on 23.03.2018 in notification No. G1/1585/2017, dt:17.03.2018 for acquisition situated at Ananthagiri village of Ellanthakunta mandal for a further period of (12) months beyond 23.03.2019. The Authorized Officer / Revenue Divisional Officer, Sircilla shall take necessary action for acquisition of required land at the earliest.
