Through the reference 2<sup>nd</sup> cited, the Special Deputy Collector , Unit VII & Revenue Divisional Officer, Sircilla has submitted proposals with request for extension of time for submission of declaration as the Form-C Notification in accordance with G.O Ms.no.120 Revenue (JA & LA) Dept., dt.30.06.2017 under section 11 with exemption of section 10-A of the RFCTLARR Act, 2013 as amended through RFCTLARR (Telangana Amendment) Act, 2016 (Act No.2/2017) to acquire an extent of Ac.324.33  $\frac{3}{4}$  gts of land situated in the limits of **Burugupalli, Boinpalli, Korem, Stambampalli, Thadagonda villages of Boinpalli Mandal, Dacharam village of Ellanthakunta Mandal, Baddenapalli, Nerella, Narsimhulapally villages of Thangallapalli Mandal, Kodimunja village of Vemulawada Rural Mandal and Shatrajpalli village of Vemulada Mandal** for excavation of New Broad Gage Railway line from Manoharabad to Kothapalli Project which is going to be lapse due to Election to the Local Bodies and some other works and requested to extend the notification which was issued on 22.02.2019 for a period of (12) months.
